G20 Parliamentary Conference on Women's Health in Cape Town, South Africa



EPF is organising the G20 Parliamentary Conference on Women's Health: "The Economic Benefits of Investing in Women's Health" in Cape Town from 5-6 May 2025, in collaboration with the Southern and East African Parliamentary Caucus on SRHR and IPAS. This high-level event will convene 40 Members of Parliament from G20 countries, representatives from Africa, OECD-DAC countries, the Southern African Development Community (SADC), and the East African Legislative Assembly (EALA).

Parliamentary Delegation to Visit Sri Lanka

From 26-30 May 2025, Members of Parliament from Austria, Belgium, Denmark, Finland, Sweden, the UK and the European Parliament will visit Sri Lanka on a study tour organised with the Family Planning Association of Sri Lanka (FPA). During the visit, the delegation will hold high-level meetings with ministries, local parliamentarians and embassies, as well as site visits in clinics, service delivery points and rural communities.

Call for Action for Women's Rights Signed by 80 MPs from Across Europe and Canada



At the CSW69, **80 parliamentarians signed** a declaration calling for **women's rights and standing in solidarity against the global rise of reactionary politics led by Donald Trump** and other ultraconservative forces. **"This is the message we brought**

to the United Nations this week for the 69th Commission on the Status of Women. There are women and men in this world who refuse to accept a future built on submission and oppression. There are still women and men who choose respect, equality, and freedom over fear and control", reads the statement.

From 9-13 March 2025, the EPF delegation participated in the CSW69 opening session, where global leaders reaffirmed commitments to the Beijing Platform for Action. The delegation also traveled to Washington D.C. to discuss US funding for SRHR and possible transatlantic cooperation with key members of Congress, including Rep. Sarah McBride (Delaware), Rep. Lois Frankel (Florida), Rep. Grace Meng (New York), Rep. Dina Titus (Nevada) and Rep. Kamlager-Dove (California).

parliamentary delegation Philippines supports Filipino policymakers and civil society in advancing adolescent health through the **Teenage Pregnancy** Prevention Bill and comprehensive sexuality education (CSE). Following last January's visit to the Philippines, nine MPs signed a statement to call for stronger international coordination against disinformation and more transparency in public funding.

New Report Released: "Beyond the Chaos, a New World is Emerging"



On 3 March 2025, EPF released a new report authored by Neil Datta on Trump's strategy for a new global order aimed at redefining SRHR, gender equality and human rights. On 26 March 2025, Neil Datta presented "Beyond the Chaos, a New World Is Emerging" to the Group of Experts on Action against Violence against Women and Domestic Violence (GREVIO) at the Council of Europe.

SRHR and ODA News

On 7 March, the **EUROPEAN COMMISSION** published the EU Roadmap for Women's Rights, reaffirming its commitment to gender equality. Building on the Gender Equality Strategy 2020-2025, the Roadmap focuses on combating gender-based violence, ensuring equal pay, improving work-life balance and increasing political participation. It highlights progress made and areas where further action is needed and briefly mentions the need to support women's health by strengthening complementing Member States' actions on access to "Despite our requests for a commitment to sexual and reproductive rights, we have seen only timid progress," said MEP Melissa Camara (Greens/EFA, France).

FRANCE launched its **Feminist Foreign Policy Strategy 2025-2030**: this is the first time that France has fully integrated gender equality into its foreign policy framework. The strategy has five priorities: defending SRHR, strengthening feminist diplomacy within multilateral institutions, increasing funding for feminist organisations, mainstreaming gender equality in global transformations such as climate and Al, and promoting comprehensive sexuality education. France is also positioning itself as a **coalition builder** to counter the global backlash by hosting the 4th edition of the **Shaping Feminist Foreign Policy Conference.**

In **THE NETHERLANDS**, **o**n 4 March, the House of Representatives voted on three **motions related to abortion care**, submitted by members of Christian parties (SGP and NSC) and supported by a coalition including far-right party FvD, PVV, BBB, and others. These proposals, framed as efforts to evaluate current legislation and the rise in abortion rates, risk **undermining women's autonomy and reproductive rights**. The first motion, calling for an investigation into

whether the abolition of the mandatory reflection period contributed to an increase in abortions, was adopted. The second motion, requesting an early evaluation of the **Termination of Pregnancy Act**, was also adopted. However, a third motion proposing that the reasons for abortion be registered and published annually was not adopted.

POLAND's first ever "abortion clinic" opened in Warsaw on International Women's Day. The facility does not provide medical services itself, but it offers a space for women to take abortion pills that they can order in advance. The clinic, set up by the activist group Abortion Dream Team, also offers pregnancy tests and advice on how to terminate a pregnancy, including helping to arrange and pay for surgical abortions abroad.

In IRELAND, in response to anti-abortion MP Carol Nolan's question, the government reaffirmed its commitment to comprehensive sexual and reproductive health and rights (SRHR) as part of its international development policy. While abortion provision is not a central element of Ireland's overseas aid, funding supports a range of essential services, including contraception access, maternal health, HIV prevention, and post-abortion care.

On 26 March, THE UK government announced immediate cuts to the aid budget, reducing the ODA to 0.3% of GNI by 2027 to fund increased defence spending. Concerns about the aid cuts were raised earlier in March during a debate in the House of Lords by Lord Bruce and Baroness Sugg; an Early Day Motion was tabled; and a cross-party committee, including MP Sarah Champion, Chair of the International Development Committee and Co-Chair of the UK APPG on SRHR, wrote to the Prime Minister expressing concern about the cuts and their impact on global aid efforts.

NORWAY's new one-party Labour government has appointed strong SRHR advocates: the Ministry of Development Åsmund Aukrust and State Secretary Stine Renate Håheim, both long-time SRHR supporters. Aukrust has already pledged to prioritise gender equality and SRHR, although financial commitments remain to be seen. All eyes are now on 15 May, when the revised budget for 2025 will be announced.

In his first major move as **CANADA**'s new Prime Minister, **Mark Carney** has abolished the position of **Minister for Women and Gender Equality** and folded it into a broader ministry. This decision is a major setback for gender equality. Without dedicated leadership, key initiatives such as the **National Action Plan to End Gender-Based Violence** risk being sidelined.

Challenging the Backlash

Legal Actions Against Misinformation on Sexuality Education in the Netherlands. Dutch knowledge center Rutgers is taking legal action against Civitas Christiana, an ultra-conservative organisation spreading falsehoods about Rutgers and the Week of Spring Fever—an annual program providing structured lessons on relationships, resilience, and sexuality in schools. By challenging these falsehoods, Rutgers stands with teachers, parents, and students to ensure that all children receive accurate, ageappropriate education in a safe and supportive environment.

Appeal to Portuguese **Parliament** Support **UNFPA** SRHR. Nineteen CSOs addressed the Parliament and Government of Portugal at a time of profound changes in international cooperation to call them to strengthen efforts for peace and human dignity. Amid the crises of government, the Portuguese APPG remains aware of the urgency of the global situation: the reality tends to worsen with each passing day, with more maternal, child and neonatal deaths and morbidities, and we are witnessing an escalation of situations of violence against the principles of **Equality and Human Rights**
